The Emergency Petition for a Writ of Mandamus filed on October 24, 2003 (the “Petition”) by Kensington International Limited and Springfield Associates, LLC (the “Petitioners”) and the underlying recusal motion raise serious issues with respect to the District Court’s administration of each of the five asbestos-related chapter 11 cases pending in the District of Delaware (together, the “Five Asbestos Cases”), all of which this Court has assigned to the Honorable Alfred M. Wolin. The undersigned represent the Official Committee of Unsecured Creditors appointed to represent the interests of all unsecured creditors (other than asbestos claimants) (the “Armstrong Committee”) in one of the Five Asbestos Cases, In re Armstrong World Industries, Inc., et al., Case Nos. 00-4471, 00-4469, 00-4470 (the “Armstrong Cases”). The Armstrong Committee submits this Statement because, should this Court grant the Petition, the impact of such a ruling could not be confined to the Owens Corning Cases and would necessarily, for the reasons discussed herein, effect the Armstrong Cases as well.

FACTS

By order dated November 27, 2001, then-Chief Judge Edward R. Becker of the United States Court of Appeals for the Third Circuit ordered the transfer of all Five Asbestos Cases from the Bankruptcy Court to the Honorable Alfred M. Wolin

of the United States District Court for the District of New Jersey.¹ Chief Judge Becker stated his “considered judgment that these bankruptcy cases, which carry with them tens of thousands [of] asbestos claims, need to be consolidated before a single judge so that a coordinated plan for management can be developed and implemented.” Chief Judge Becker deemed this assignment and consolidation “critically important to the administration of justice.” (A copy of Chief Judge Becker’s order is attached to this Statement as Exhibit A.)

On December 10, 2001, in keeping with Chief Judge Becker’s order, District Judge Wolin referred portions of the Five Asbestos Cases back to the Bankruptcy Court, but expressly ordered that “the withdrawal of the reference is specifically contemplated with respect to asbestos-related claims and issues.” (A copy of this order is attached to this Statement as Exhibit B.) On December 28, 2001, District Judge Wolin entered an order, applicable to each of the Five Asbestos Cases, appointing William A. Drier, Esq., David R. Gross, Esq., C. Judson Hamlin, Esq., and Professor Francis E. McGovern as “Court Appointed Consultants” (the “Consultants”) for each of the Five Asbestos Cases. (A copy of this order is attached to this Statement as Exhibit C.)

On October 10, 2003, the Petitioners, creditors in the In re Owens Corning, et al. (Case Nos. 00-3387 through 00-3854) chapter 11 asbestos cases (the “Owens Corning Cases”), filed a motion seeking to recuse District Judge Wolin from further participation in the Owens Corning Cases (the “Recusal Motion”) on the grounds that the Consultants advising District Judge Wolin in the Five Asbestos Cases did not qualify as “disinterested;” the Petitioners maintained that certain of the Consultants also actively represent asbestos future claimants in another major asbestos chapter 11 case pending in this Circuit -- G-I Holdings, Inc., f/k/a GAF Corporation, and its affiliates. On October 24, 2003, the Petitioners filed the Petition with this Court. On November 3, 2003, this Court entered a scheduling order requiring all responses to the Petition to be filed by November 21, 2003.² The Armstrong Committee submits this Statement as a response.³

STATEMENT

District Judge Wolin has been actively involved in the Armstrong Cases. Based on a review of their fee applications, so have the impugned Consultants. Indeed, Armstrong has paid one-fifth of the Consultants’ fees. Given District

² On November 5, 2003, in response to the Petition, District Judge Wolin issued an order providing, among other things: “ORDERED that any hearing or other proceeding presently scheduled before this Court in any of the above-captioned chapter 11 cases [the Five Asbestos Cases] is hereby adjourned *sine die* and this Court’s participation in any matter in those cases is stayed pending further Order of the Court” (A copy of this order is attached to this Statement as Exhibit D.) Despite this order, and the proposed Order to Show Cause seeking to enforce this order filed by the Armstrong Committee on November 7, 2003, Bankruptcy Judge Newsome proceeded with confirmation of Armstrong’s “cram down” plan of reorganization on November 17 and 18, 2003 – in the absence of District Judge Wolin and without regard to the issues raised by the Petition.

Judge Wolin's significant involvement and the impugned Consultants' apparent involvement, the issues raised by the Petition apply to the Armstrong Cases as well.

Despite the efforts of the Armstrong Committee, District Judge Wolin and Bankruptcy Judge Newsome have refused to suspend the Armstrong Cases pending resolution of the issues raised by the Petition.⁴ Most recently, on November 17 and 18, 2003, Bankruptcy Judge Newsome, over the objection of the Armstrong Committee (and the debtors' \$1.65 billion class of general unsecured claimants who overwhelmingly voted against the plan), proceeded with confirmation of Armstrong's plan of reorganization in the absence of District Judge Wolin (contrary to this Court's order mandating his involvement) and in complete disregard of the potential impact of the issues raised by the Petition.

Given the active involvement of District Judge Wolin and the apparently broad participation of the Consultants in each of the Five Asbestos Cases, including the Armstrong Cases, the impact of the issues raised by the Petition and the underlying recusal motion clearly extend to the Armstrong Cases. The Armstrong Cases are also at a critical juncture; these cases have advanced further than any of the other Five Asbestos Cases. The asbestos-related issues which both

⁴ In response to the issues raised by the Petition, among others, the Armstrong Committee has filed (a) a motion for continuance of the Armstrong confirmation hearing, (b) a proposed Order to Show Cause before the District Court seeking to enforce District Judge Wolin's November 5, 2003 order adjourning *sine die* all hearings and proceedings in the Five Asbestos Cases, and (c) objections to confirmation of the Armstrong Plan.

this Court and the District Court stated shall be determined by a single District Court Judge (the resolution of which will obviously have an effect on the other four Asbestos Cases) are ready to be heard. Should this Court grant the Petition, it should not confine its ruling to the Owens Corning Cases. Rather, that ruling should apply to each of the Five Asbestos Cases – including the Armstrong Cases. Accordingly, the Armstrong Committee respectfully requests that this Court extend any relief granted in the Owens Corning Cases to the Armstrong Cases.

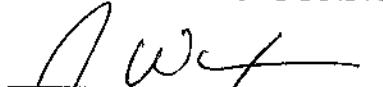
CONCLUSION

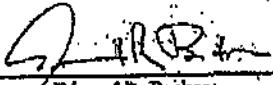
DESIGNATION OF A DISTRICT JUDGE

single judge so that a coordinated plan for management can be developed and implemented. It is
contemplated that Judge Wollin will assign a portion of these cases to various bankruptcy judges
sitting in the District of Delaware so they may assist in moving these matters forward. As a

significant portion of the asbestos cases in this country are proceeding under the aegis of this litigation, I deem this assignment and consolidation critically important to the administration of justice.

ORDERED that the following Order applies to the lead cases identified in the caption of this Order and to all cases filed as related cases thereto, and it is further

ORDERED that In re W.R. Grace & Co., Bankruptcy No. 01-1139, is hereby referred to the Honorable Judith K. Fitzgerald is further

ORDERED that In re Armstrong World Industries, Inc., Bankruptcy No. 00-4471, is hereby referred to the Honorable Randall J. Newsome, and it is further

ORDERED that In re Federal-Mogul Global, Inc., Bankruptcy No. 01-10578, is hereby referred to the Honorable Randall J. Newsome, and it is further

ORDERED that In re Owens Corning, Bankruptcy No. 00-3837, is referred to the Honorable Judith K. Fitzgerald before whom it was previously pending, and it is further

ORDERED that In re USG, Bankruptcy, No. 01-2094, is hereby referred to the Honorable Randall J. Newsome before whom it was previously pending, and it is further

ORDERED that Judges Fitzgerald and Newsome will cooperate between themselves and with this Court in the scheduling of the above-captioned five cases to facilitate the expeditious administration of the debtors' estates in bankruptcy, and it is further

ORDERED that all persons are on notice that this Court may, sua sponte, upon recommendation received from the Bankruptcy Judges, or upon motion, withdraw the references made by this Order with respect to specific proceedings or issues as may be required by law or as may from time to time be deemed advisable by the Court to facilitate the efficient resolution of the several cases and/or to adjudicate common issues among them and it is further

ORDERED that the withdrawal of the references is specifically contemplated with respect to asbestos-related claims and issues, provided however that the Court's authority to withdraw the references shall not be limited to that issue nor by whether a particular proceeding is considered core for the purposes of the jurisdiction of the Bankruptcy Court under the United States Code, and it is further

ORDERED that all pleadings, applications, or documents

concerning these cases shall be filed with the Clerk of the Bankruptcy Court for the District of Delaware in accordance with applicable procedures and Local and Federal Rules of Bankruptcy Procedure, and it is further

ORDERED that counsel for the debtors shall transmit a copy of each Omnibus Hearing Agenda Letter to this Court simultaneously with filing that letter in the Bankruptcy Court, and debtors' counsel shall immediately contact this chambers by telephone to arrange the mode of transmittal of the Agenda Letters, and it is further

ORDERED that at the status conference in these cases presently scheduled for December 20, 2001, this Court will solicit views from the parties with respect to which specific proceedings, and particularly which asbestos-related proceedings, the references to the Bankruptcy Judges should be withdrawn, and it is further

ORDERED that, from the date of this Order, the Bankruptcy Judges will conduct an initial review of all proceedings and issues presently pending before them in the above-captioned cases to determine whether, as a matter of statutory jurisdiction or to facilitate the several cases and/or to adjudicate common issues among them, the reference should be withdrawn as to any of them, and it is further

ORDERED that upon completion of their review, the Bankruptcy

Judges shall recommend to this Court as to which proceedings or issues the references should be withdrawn, and it is further

ORDERED that this Order shall be without prejudice to the right of any party to move to withdraw a reference with respect to a particular proceeding, and it is further

ORDERED that nothing in this Order shall be construed to require that the Bankruptcy Court render formal findings or recommendations with respect to a withdrawal of the references or a determination of the core/non-core nature of a particular proceeding unless a party in interest files a motion requesting a determination of the core/non-core status of a particular proceeding, and it is further

ORDERED that all proceedings currently pending before the Bankruptcy Judges will continue to be handled by them in accordance with the provisions of 28 U.S.C. § 157 and this Order, subject to further Order of this Court, and it is further

ORDERED that all previous orders in the above captioned cases shall continue in force except as modified or superseded by the terms of this Order.

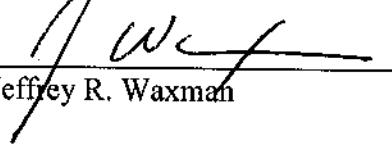
