Network Print Device Maintenance

1. Purpose

To procure a single maintenance contract for all of the U.S. Third Circuit Court of Appeals (hereafter "Court of Appeals") networked print devices, including Multi-Function Devices (MFDs)/photocopiers.

2. Requirements

- Maintenance must cover all makes and models and include toner and any service or repairs. The brands represented are Hewlett Packard printers and Konica copiers/printers/scanners. (List attached)
- Maintenance must be proactive with automated notification of toner and maintenance needs for networked devices. The method for facilitating device status via the Internet must be technically acceptable to the Court of Appeals.
- The contract must provide for replacement, installation and configuration of printers if repairs are not possible.
- Toner and parts must be OEM.
- Service response time must be four (4) hours or less to ALL listed Court of Appeals locations.
- Service calls may be placed by authorized individuals at each Court of Appeals location. (List of authorized callers will be provided by COA.)
- Billing for MFDs and printers must be through a single invoice and there is a preference for a single contract.
- The Court of Appeals must have the option to configure the contract for either monthly or quarterly payments.
- Billing format must be customizable to Court of Appeals needs.
- The Court of Appeals must be able to add and remove covered devices to the contract as needed.

3. Scope

The contract must provide for coverage of all print devices owned by the Court of Appeals in the following locations:

4. Billing

On a monthly or quarterly basis (as determined by the COA) the contractor will submit a billing statement for payment. The statement will include a breakdown of any maintenance calls, onsite repairs, and equipment replacements.

5. Pricing Model

The Court of Appeals will add and remove printers from the contract as necessary with the understanding that pricing will then vary. For the purposes of this proposal, pricing should reflect the current list of devices (attached) and be quoted as “per page.”

6. Period of Performance

The period of performance for this SOW is from the date of award. The COA will award a one (1) year contract effective on the date of award.

Offers will be evaluated and award made solely on the basis of prices offered on the year’s requirements.

7. Solicitation Provisions Incorporated by Reference (Provision B-1, Sept. 2010)

This solicitation incorporates one or more solicitation provisions by reference, with the same force and effect as if they were given in full text. Upon request, the contracting officer will make their full text available.
