CJA 21s

Services of Investigators, Translators, Experts, and Other Services

It is recommended that counsel seek prior authorization for services. Counsel should submit a CJA 21 Authorization in eVoucher. With prior Court authorization, the statutory maximum for cumulative services in a case is \$2,800. Without prior authorization, the statutory maximum for cumulative services in a case is \$900. If services were completed before January 1, 2023, the maximum with prior court authorization is \$2,700 and without prior court authorization remains at \$900.

Paralegals, legal assistants, and law students may be compensated at an hourly rate less than that paid to appointed counsel.

Photocopy Rates

Copies made “in-house” will be reimbursed in an amount up to and including \$.10 per page. Please show expenses on the Expense Tab, the number of copies made and the cost per copy. All photocopy charges incurred by a commercial vendor require a receipt for charges over \$50.00. The receipt should be attached as a PDF document under the Documents tab and identified as a receipt for copy work.

Postage

Postage is considered a reimbursable expense. Courier delivery charges will be allowed only for rare occasions. Dilatory conduct of counsel is not a justifiable reason for reimbursing such special services. A receipt is required for charges over \$50.00. The receipt should be attached as a PDF document under the Documents tab and identified as a receipt for postage.
